#### **Assessment Billing Dates**

Water Company Annual Assessments are billed directly by the Water Company in June and October of each year in conjunction with the winter and summer water usage meter reading schedule. Billing for annual assessments are split between the two meter reading periods as defined under the link [Fees](#) and the sub-link [Summary of Assessments, Rates, and Fees](#).

#### **Water Usage Meter Periods**

Winter Period is approximately 8 months, from the end of September thru May of the following year  
Summer Period is approximately 4 months, from the end of May to the end of September of the same year

#### **Outside Watering Restrictions**

The outside watering schedule for property having odd numbered addresses is limited to Sunday, Tuesday, and Thursday. No outside watering is to be done during the hours of 10:00 AM through 6:00 PM.

The outside watering schedule for property having even numbered addresses is limited to Monday, Wednesday, and Friday. No outside watering is to be done during the hours of 10:00 AM through 6:00 PM.
